TECHNICAL EDUCATION – Establishment of a Polytechnic by Sakthi Foundation at Athani in Periyar District during 1981-82 – orders issued.

Order:

The President, Sakthi Foundation, Coimbatore has sent a proposal to the Govt. for the establishment of a Polytechnic at Athani in Periyar District. The Director of Technical Education, who has recommended the proposal has stated that Periyar District is fast becoming an industrial region. Many industries are likely to come up in future as enough potential is there and vast resources are available in the District. The employment potential for technical trained young men in the industries of the Periyar District and in these of the neighbouring district of Salem, Coimbatore and Trichy is vast. The avenues for self employment and employment in the public sector undertakings are many for properly trained technicians. In view of the above reasons, he has requested the Govt. to approve the proposal.

2. The Govt. after careful consideration approve the proposal of the Director of Technical Education and sanction the starting of the Polytechnic at Athani in Periyar District by Sakthi Foundation, Coimbatore in the name and style of "Sakthi Institute of Technology" during 1981-82 subject to the following conditions:-

1. The management of the private Polytechnic should be required to create an endowment of Rs. 5 lakhs in cash before the opening of the Institution and provide lands to the extent of fifty acres; and
2. The total non-recurring cost (capital cost) of opening of the private Polytechnic should be shared between the private management and the Govt. in the ratio of 66⅔% and 33⅓% respectively.
3. The recurring cost (maintenance cost) will be shared by the Govt. and the management in the ratio of 90:10.
4. Before starting any other new course in the Polytechnic the approval of Govt. should be obtained.

3. The Director of Technical Education is requested to ensure that the management provides 50 acres of land and creates an endowment of Rs.5 lakhs in cash in conformity with the orders issued in G. O. Ms. No. 407 Education dated 3.3.78.

4. The Govt. permit the Director of Technical Education to introduce the following courses in the above said Polytechnic to be stated with effect from 1981-82.

1. Diploma in Mechanical Engineering
2. Diploma in Civil Engineering
3. Diploma in Electrical Engineering
4. Diploma in Electronics
5. Diploma in Agricultural and Farm Equipment Technology
6. Metallurgy

The intake of the polytechnic will be 180 students.

5. The Govt. sanction the following ultimate cost on the establishment of the Polytechnic referred to in para 2 above to the borne by the Govt. and the Management as per the G. O. read above

6. Sanction is accorded to the employment of the staff required for the year 1981-82 as mentioned in the annexure to this order on the scales of pay noted against each for the Polytechnic. The Director of Technical Education is informed that there should not be any expenditure to the Govt. during the current year.

7. The incumbent of the post mentioned in para 6 above are eligible to draw Dearness Allowance and House Rent Allowance and other allowances in addition to their pay as per rules in force from time to time.

8. The Director of Technical Education is also requested to obtain the approval of Southern Regional Committee of All India Council for Technical Education for starting the Polytechnic besides getting the concurrence of Tamil Nadu State Board of Technical Education and Training.

9. The expenditure should be debited to "277. Education F. Technical Education – AC. Polytechnic – Scheme in Sixth Five Year Plan – II. State Plan – JB. Direct grants to aided Polytechnics – 09. Grants in aid (DPC 277F ACJB 0900)
